# **Guidelines for Authors**

### GENERAL

The City University International Journal of Computational Analysis (CUIJCA) is published annually by City University of Science and Information Technology, Peshawar, Pakistan. It adheres to the guidelines established by the Committee on Publication Ethics (COPE), as outlined in the "Recommendations for the Conduct, Reporting, Editing, and Publication of Scholarly Work," which can be accessed here.

#### **Submission of Manuscripts**

Manuscripts containing original material are accepted only. Neither the article nor any part of its essential substance should be submitted for publication elsewhere before appearing in this journal.

#### **Online Submission**

The corresponding author has to create an account or login to an existing account on our website. Then he has to follow a 5-step easy submission process. The manuscript must be blinded, not showing authors details; names, designations, departments, institutions, cities etc. The details of authors are to be uploaded in metadata. The supplementary files, including data files, fee submission document etc. may be added, if desired.

### Language

CUIJCA is published in English. Try to follow the British English but do not hesitate to use American English where convenient.

# Writing style & Format

Please use Times New Roman, size 12, justified with 1.5 line spacing. Put tables and illustrations (figure/ chart/ image) where stated, not at the end of the document.

### Title of the manuscript

**Conciseness:** Ensure titles are brief yet informative, capturing the essence of the research succinctly.

Clarity: Use clear and understandable language to convey the main topic and purpose of the study.

**Relevance:** Ensure titles directly relate to the content of the manuscript, reflecting its scope and focus accurately.

**Specificity:** Be specific in the title, highlighting key aspects or findings of the research without ambiguity.

Accuracy: Ensure titles accurately represent the content and avoid misleading or exaggerated claims.

**Language:** Titles must be in English, with the first letter of each word capitalized. Avoid abbreviations, except for the most common ones when necessary.

**Keywords:** Consider incorporating relevant keywords to enhance searchability and visibility of the manuscript.

**Originality:** Strive for originality in title creation to distinguish the research and attract readers' interest.

Consistency: Maintain consistency in title formatting and style throughout the manuscript.

**Review:** Review and revise titles carefully to ensure they effectively convey the significance of the research.

### Key words

Select concise, relevant keywords representing applied mathematics and computational methods. Ensure diversity by including terms covering mathematical models, algorithms, and computational simulations. Maintain consistency in terminology throughout the manuscript. Tailor keywords to the target audience, focusing on relevance to researchers and practitioners. Review keywords carefully for accuracy and enhance discoverability with five to ten well-chosen terms.

### Abbreviations

Standard abbreviations should be used only. For every abbreviation the full word should be given at first with abbreviation in parenthesis. Well known and frequently used abbreviation may be used as such.

### **Tables and Illustrations**

There is no limit on the number of tables and illustrations (graphs/ charts/ images). These should be as per rational demand of the manuscript.

Each table and illustration should stand by itself; showing all its contents/ meanings without going into the text.

Each table and illustration must have a serial number and a title; above the table and below the illustration. The title of table and illustration should be summary of the tile of the manuscript.

Illustrations should be of good quality.

Where required, table or illustration should have an accompanying legend.

If a table or an illustration has been reproduced from a published work the source must be given.

The author must submit the permission from the author/ publisher to reproduce the previously published illustration.

# References

### **In-Text Citations:**

In-text citations should be used to acknowledge sources within the manuscript.

Each in-text citation should be numbered consecutively in square brackets, such as [1], [2], etc.

The numbers assigned to citations should correspond to the order in which the sources are cited in the manuscript.

### **Reference List:**

A reference list should be included at the end of the manuscript, listing all sources cited in numerical order.

References should be formatted according to the IEEE citation style.

Each reference should include the author(s)' name(s), title of the work, title of the publication (if applicable), publication year, volume (if applicable), issue (if applicable), page numbers, and DOI (if available).

### **Formatting Examples:**

Double-check all details, including author names, publication titles, and publication years, to avoid errors.

### **Units of Measurements:**

Please use Systems International (SI) units, where possible.

# **Publication Malpractice**

The City University International Journal of Computational Analysis (CUIJCA) is dedicated to maintaining the highest standards of ethical conduct and integrity in scholarly publishing. As such, we have established the following publication malpractice statement to address any instances of misconduct and ensure the integrity of the journal's content:

### Plagiarism and Academic Misconduct

Plagiarism, including the reproduction of others' work without proper citation or attribution, is strictly prohibited.

Authors are expected to ensure the originality of their submissions and properly cite sources when using the work of others.

Plagiarism, defined as the presentation of another author's language, text, thoughts, ideas, or expressions as one's own original work, is strictly prohibited by the City University International Journal of Computational Analysis (CUIJCA). This includes instances of self-plagiarism, such as duplicate or redundant publication, text recycling, and salami slicing. CUIJCA adheres to the

guidelines, standards, and policies established by COPE (Committee on Publication Ethics) and the Higher Education Commission (HEC), Pakistan, regarding plagiarism.

To ensure the authenticity of submitted manuscripts, CUIJCA employs TURNITIN to check the similarity index of each submission. Manuscripts with a similarity index up to 50% are reviewed by the editorial team, and the similarity reports are conveyed to the authors. However, manuscripts exceeding a similarity index of 50% are rejected without further review or processing. According to the guidelines set forth by the Higher Education Commission (HEC), Pakistan, a similarity index of less than 20% is required for the authenticity of the work. If the report has a minimum similarity index of less than or equal to 19%, the benefit of the doubt may be given to the author. However, if any single source has a similarity index greater than or equal to 5%, it needs to be checked as a potential basis of plagiarism. In cases where the similarity is due to drawing upon the author(s) own work(s), these instances may be considered acceptable and not used to penalize the author(s), as long as it does not result in duplicate publication. Additionally, levels of EDS (Electronic Detection System) may be considered for further interpretation as per the EDS Manual.

Authors also have the option to submit their own similarity report as a supplementary file if they have already checked the manuscript using TURNITIN or a similar software. Any attempt of plagiarism is considered academic dishonesty and will be dealt with accordingly.

If plagiarism is discovered after the publication of an article, it will be retracted, and the authors may face permanent or temporary debarring from submitting to the journal. The parent institution of the authors may also be notified for further departmental proceedings against the author. In cases where plagiarism is detected prior to publication, the current article will be rejected, and the authors may be barred from submitting to the journal for one or more years.

CUIJCA is committed to upholding the highest standards of publication ethics and integrity, and we take a zero-tolerance approach towards plagiarism. We urge all authors, reviewers, and stakeholders to adhere to these ethical principles to maintain the credibility and reputation of scholarly publishing.

# Repository

For CUIJCA, authors are permitted to self-archive and make their articles publicly accessible on their employer's internal website, institutional repositories, and/or funder repositories. We strongly encourage authors to deposit the Version of Record and provide the URL/DOI of their published article in any repository. This ensures that the definitive version is readily available and increases the likelihood of correct citation.

Here's a summary of how authors can share different versions of their article:

# Submitted Version (Author's Original Manuscript):

Authors can share their submitted version (AOM) on social media, scholarly collaboration networks, personal websites, or preprint servers (e.g., arXiv, bioRxiv) for non-commercial use. Posting on a preprint server is not considered duplicate publication. Upon acceptance, authors should acknowledge acceptance by stating: "This article has been accepted for publication in CUIJCA."

# Accepted Version (Author Accepted Manuscript):

Authors can share their accepted version (AM) after acceptance, including on platforms like Facebook, Google groups, LinkedIn, or Twitter. We recommend inserting a link from the posted AM to the published article with the following text, including the DOI: "This is an Accepted Manuscript of an article published in CUIJCA on [date of publication], [Article DOI]."

# Published Version (Version of Record):

Upon publication, authors can link to the Version of Record (VOR) using the DOI or post the article PDF on non-commercial websites and repositories of their choice, ensuring the connection between different versions. Authors can add text such as: "This is an [title of Accepted Manuscript / Author's Original Manuscript] of an article published in CUIJCA on [date of publication], available at [Article DOI]."

By linking different versions of their article, authors enhance accessibility and facilitate proper citation of their work in CUIJCA.

# Authorship Criteria

Any concerns or issues related to authorship or contributorship, including instances of ghost authorship, guest authorship, and other distortions, will be addressed in accordance with COPE Guidelines.

Corresponding authors bear the responsibility of ensuring that all co-authors have reviewed and approved the final version of the manuscript and are responsible for maintaining communication with the editorial team throughout the publication process.

Changes in authorship, including additions, deletions, or rearrangements, must be agreed upon by all affected authors and communicated to the editorial team with appropriate justifications. The City University International Journal of Computational Analysis (CUIJCA) does not support changes to the author list, including additions and deletions, after the editorial process has begun.

Colleagues aiding in study design

Reviewers of the manuscript

Individuals providing laboratory support

# Withdrawal Policy

Submitting the same manuscript to multiple journals simultaneously is highly unethical. Should an author decide to withdraw their manuscript during processing, they must send an official email to the editor-in-chief requesting withdrawal. No manuscript will be considered officially "withdrawn" without such notification. It is important to note that a manuscript cannot be withdrawn after it has been accepted by the journal.

# **Correction Policy**

In cases where a manuscript has a minor flaw that does not significantly impact its findings, the editor may choose to issue a correction rather than a retraction, for the benefit of the scientific community. Depending on the source of the mistake, either an ERRATUM or CORRIGENDUM will be issued.

An ERRATUM is issued if the mistake originated from the production process handled by the publisher.

A CORRIGENDUM is issued if the mistake is due to an author's miscalculation or oversight.

# **Appeal Process**
